BOROUGH OF SOUTH CONNELLSVILLE FAYETTE COUNTY, PENNSYLVANIA

ORDINANCE NO. 2022- 329

AN ORDINANCE OF THE BOROUGH OF SOUTH CONNELLSVILLE, FAYETTE COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 308, AS AMENDED, TO DESIGNATE, ADD, AND MAKE A PORTION OF VINE STREET AS NO PARKING; REPEALING ALL INCONSISTENT ORDINANCES OR PARTS THEREOF; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, there exists within the Borough of South Connellsville certain areas where parking of vehicles upon the roadways interferes with emergency and other public or essential services or travel; and

WHEREAS, the Borough of South Connellsville has established no parking areas within the Borough with Ordinance No. 308; and

WHEREAS, a study has been conducted and it has been determined that with respect to portions of Vine Street: (i) the distance between the center of the center line pavement markings and the curb or edge of roadway is less than 19 feet; (ii) at the related intersections, the available corner sight distance for drivers on connecting roads is less than the necessary minimum stopping sight distance value for the driver on any through roadway; and

WHEREAS, the Borough of South Connellsville has the power to erect official trafficcontrol devices pursuant to 75 Pa.C.S.A. § 6122, 67 Pa. Code § 212.5, and other statutory and regulatory sections.

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of South Connellsville, Fayette County, Commonwealth of Pennsylvania, and it is hereby enacted and ordained as follows:

Section 1. Addition of Portions of Vine Street to No Parking Zones. The Borough hereby amends Ordinance No. 308, Section 402, to add and make the west side of "Vine Street" from Wine Street to Pine Street as a "No Parking Zone" for which a sign designating the same shall be erected, as follows:

Street	Side	Between
Vine Street	Western Side	Wine Street and Pine Street

Section 2. <u>Authorization</u>. The Borough hereby authorizes all Borough officials and employees to take any and all actions necessary to effectuate and enforce the addition of said portion of Vine Street as a "No Parking Zone" and this Ordinance, including, without limitation, the erection of any sign and the painting of any curbing or streetway.

Section 3. <u>Severability</u>. It is herein declared that the provisions of this Ordinance are severable, and if any provisions, portions, or sections of this Ordinance are declared to be illegal, invalid, or unconstitutional, the decisions of any Court, which makes declarations, shall not impair or affect any of the remaining portions of this Ordinance.

Section 4. Repealer. Any ordinance or part of any ordinance that conflicts with the provisions of this ordinance is hereby repealed to the extent of any such conflict on the effective date of this ordinance.

Section 5. <u>Effective Date</u>. This Ordinance shall become effective immediately.
