## ORD. NO. 315

AN **ORDINANCE OF** THE **BOROUGH OF** SOUTH CONNELLSVILLE, FAYETTE COUNTY, COMMONWEALTH OF PENNSYLVANIA, REGULATING THE USE OF VEHICLES ON **GROUNDS** THE OF THE SOUTH CONNELLSVILLE **PLAYGROUND** 

WHEREAS, the Borough of South Connellsville (the "Borough") desires to prevent the operation of certain vehicles on the grounds of the South Connellsville playground to ensure the health, safety and welfare of the Borough and its citizens.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED,** and it is hereby enacted by the Borough Council for the Borough of South Connellsville, Fayette County, Commonwealth of Pennsylvania, as follows:

The term vehicle for the purpose of this ordinance will be divided into two major classifications:

- Motorized vehicles including but not limited to; cars, trucks, motorcycles, motor scooters, mopeds, quads, trikes, and side by sides
- 2) Non-motorized vehicles including but not limited to: bicycles, tricycles, and skateboards

Motorized vehicles of any type are prohibited from driving on any part of the South Connellsville playground with the following exceptions:

- 1) Vehicles used by the Borough personnel engaged in official duties or maintenance of any portion of the property
- 2) Any vehicle used by baseball or softball organizations to maintain the infields of either of the two ball fields
- 3) Contractors or utilities engaged in official duties or while in the employment of the Borough
- 4) Any vehicle authorized by the Borough Council that is used in support of special community events or otherwise given an exemption.

Non-motorized vehicles are prohibited from operating on the walking track and the infields of the two ball fields

The driver operating any motorized vehicle on any portion of the Borough playground is guilty of violating this ordinance and is subject to a minimum fine of \$200.00, with the maximum not to exceed the cost of repair of any damages incurred by their actions.

Non-motorized vehicles violating the prohibition of riding on the running track and infields are subject to a warning for the first offense and a \$50.00 fine for each additional offense.

This ordinance will replace and repeal ordinance #270
